GUIDELINES & CONDITIONS

- Members are required to show their membership card on request. Failure to produce of membership may result in full fees on service to be charged.
- Membership is valid for one year only
- Only nominated golf member can access discounted golf rates
- Membership provides access to golf course and Pelicans in Paradise 7 days a week, subject to availability. Golf Privileges do not extend to events or competitions organised by external organisations or businesses except where the terms of the contract of that event require entrants to pay green fees directly to Paradise Palms Resort & Country Club.
- The ability to book tee times will be limited to 2 weeks in advance.
- 20% Discount on Accommodation applies to rack rates only. Maximum occupancy rates apply. Upgrade fees apply for 2 bedroom apartments
- Members are required to collect a wrist band from the Golf Shop, Kiosk or bar before entering the pool, playground or mini golf area. Wristbands must be worn at all times
- Lap Pool access is available from 6am - 9pm daily. Playground and Mini Golf access is available from 7am - 9pm daily.

- Members and their guests will at all times follow any reasonable direction given by staff members of Paradise Palms Resort and Country Club
- Offensive behaviour or abuse towards other members, members of the public or staff will not be tolerated at any time and may lead to the cancellation of membership, without refund or notice.
